The Washington County Fair Campground is owned and operated by the Washington County Fair Association. The Washington County Fair Campground was constructed for use during the Washington County Fair. During other times of the year it may be rented as a campground.

Below are the terms and conditions for rental of the Washington County Fair Campground:

1. All fees will be paid prior to campground use, unless other arrangements have been made.
2. Campers who bring alcoholic beverages onto the Washington County Fair Campgrounds are responsible to follow all applicable laws and ordinances of Washington County, the State of Iowa and City of Washington. Washington County Fair Association assumes no liability for actions of persons who may have consumed alcoholic beverages on the premises.
3. All campers will park in designated campgrounds area in the southwest corner of the fairgrounds. Enter through the designated Campground and Pit Entrance.
4. No open campfires at any time.
5. Each campsite must be registered individually. One camper/trailer per campsite, but may add a tent.
6. Electrical, sewer and water hook-ups are available during most seasons.
7. Water and sewage may not be disposed of on the grounds.
8. No excessive noise in campgrounds which will disturb others.
9. No minors without parental supervision.
10. **THERE WILL BE NO REFUNDS OF MONEY PAID FOR CAMPSITES.**
11. The Washington County Fair Association reserves the right to remove anyone from the campgrounds for any reason.
12. All trash must be cleaned up from the camping spot before leaving. Dumpsters are available east of Dallmeyer Hall.
13. **The Washington County Fair Association and The Washington County Fair Board are not responsible for any damages to campers and/or people staying or visiting in the campgrounds. The Fair Board reserves the right to make changes as deemed fit because of, but not limited to, weather conditions.**
